# Anti- Ragging Committee

### Objectives :-

- 1. Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating, or handling with rudeness a fresher or a junior student.
- 2. Indulging in a rowdy or undisciplined activity which causes or is likely to cause annoyance, hardship, or Psychological harm or to raise fear or apprehension thereof in a fresher or a junior student.
- 3. Asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or Psyche of a fresher or a junior student.
- 4. Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity; place of birth, place of residence Shaneshwa or economic background.
